The history of Penn Valley Gas is more than a story about how a business was started. It's a testimony to God's sovereignty and grace. Equal Payment Plan

Simplify your bills and save money!

Here's how it works: We'll average your annual usage and divide it into 10 equal payments. Then it's simply a matter of sending in your payment every month from August to May. For added convenience, we are pleased to offer AutoPay from either a checking account or credit card.

If there's a balance due in the spring, you can simply increase your last few payments to get caught up, or pay the difference in June. If you use less gas than your average usage, your account will show a credit, which can be applied to a future plan or invoice.

Our Equal Payment Plan can help save money too. When you make payments on time, no finance charges will be assessed. Along with our commitment to making sure you always have propane when you need it, you will have the peace of mind of level monthly payments over the winter when your usage is at its highest.

If you have any questions or would like to enroll, please contact our office. Then relax knowing that you're prepared for the next heating season. If you were enrolled in the Equal Payment Plan last year, you will automatically receive this year's program information in July.

Proper Piping is Essential

Here are some simple tips about proper gas piping. If you have any questions or concerns regarding the piping at your home or business, please call our office.

- Galvanized/steel piping must be sleeved when going through masonry.
- Steel piping should not be used underground.
- Yellow polyethylene plastic gas pipe has been used for underground propane gas installations for years. It should never be used for gas piping that is above-ground or inside a building. This product is not to be confused with corrugated stainless steel tubing (CSST), which may have a yellow or black jacket to protect the tubing.

Planning Ahead for Home and Landscape Projects is Crucial

Are you planning any home projects this year, like additional living space, a generator, garden shed, pool, landscaping, or deck work? Will your project impact the propane tank and gas lines on your property in any way? Be aware of the problems that can occur when making these changes. Planning ahead is the safest and least costly way of accomplishing your project. Please call our office in the early stages of your planning to discuss and/or schedule a walk through at your home to review your plans in regards to your propane supply system. We would also welcome your contractor to contact us to verify that all current gas codes are met.

Here are four important reminders to keep in mind:

- 1. Many times landscaping changes can cause a dangerous situation when the tank lid becomes too low and fills with water, covering valves and regulators that are not designed to operate underwater. The cold winter weather will cause this water to freeze, making the situation even worse. This scenario may prevent our drivers from being able to fill your tank or turn off the gas supply in an emergency.
- 2. Tank location is important. There are safety codes that need to be adhered to including distance to structures, distance to property lines, distance to ignition sources and combustible materials, and tank accessibility. Any decking built over your tank is in violation of state regulations and unsafe.
- 3. If you or your contractor are planning to dig with any powered piece of equipment, it is your obligation to call 811, which is the PA One Call contact number. This call should notify all underground utilities servicing your property. Additionally, if your home or business is serviced by a single underground propane tank, please call us at least 3 business days prior to excavation. (PA One Call does not consider these systems a utility and therefore will not contact us.) Once we are contacted we'll come out to mark the location of the gas lines at no charge.
- 4. We recommend that you do a walk through with any landscaper or contractor doing work on your property so that they know where the underground propane tank is located. Furthermore, it is a good idea to place a tall, bold marker (such as a driveway reflector for snow removal) by the tank lid prior to work being done so that it is clearly noticeable to everyone working in its vicinity.

Grill Tips and Refills

- Always close the shut-off valve supplying your grill after each use, especially if it is hooked directly to your home.
- Always use and store cylinders outdoors in an upright (vertical) position.



- Read and follow the grill manufacturer's instructions for grill use and maintenance.
- When you need your grill tank refilled, stop by one of our convenient fill station locations.
